



## Announcement Chaturaphukpimarn Police Station

Anti-Bribery Policy and Not accepting gifts, tokens or other benefits ( No Gift Policy) from performing duties for the fiscal year ๒๐๒๓

According to the Organic Act on the Prevention and Suppression of Corruption B.E. ๒๕๖๑ Section ๑๒๘ paragraph one prescribes that any state official is prohibited from accepting property or any other benefit that can be calculated in money from anyone. other than assets or benefits that are legitimate by laws, rules or regulations issued by virtue of the provisions of the law except accepting property or any other benefits on an ethical basis According to the criteria and numbers set by the National Anti-Corruption Commission and the Code of Ethics of Police Officers, ๒๐๒๑ , item ๒(๒), honesty. perform legal duties formality of the Royal Thai Police with transparency Do not show behavior that implies exploitation. Responsible for human rights duties Be ready to be audited and held accountable. Have a good conscience . society, and item ๒(๔) thinks of the common interest rather than the personal benefit, having public mind, cooperation, and Sacrificing for the benefit of the public and create benefits and happiness for society together with the country's reform plan for the prevention and suppression of corruption and misconduct (Revised version) Schedule activities Major Reforms Activity ๔: Develop the Thai bureaucracy to be transparent. No benefit, goal ๑, item ๑.๑ gives Every government agency announces that all government officials do not accept all kinds of gifts and tokens from performing duties ( No Gift Policy).

Therefore, in order to prevent conflicts between personal interests and public interests ( Conflict of Interest), accepting bribes, gifts, tokens or any other benefits that affect the performance of duties, guidelines Practices against bribery ( Anti-Bribery Policy) and do not accept gifts, tokens or Any other benefits ( No Gift Policy) from performing duties The details are as follows:

### **Article ๑ Objectives**

๑.๑ To prevent or reduce the opportunity to accept bribes Conflicts of interest in various forms for police officers under Chaturaphukpimarn Police Station

๑.๒ To encourage police officers under Chaturaphukpimarn Police Station to have a consciousness of refusal . Receiving gifts and gratuities of all kinds from performing duties

๑.๓ Of integrity and transparency ( Organization of Integrity) of Chaturaphukpimarn Police Station to be strong and sustainable .

### **Article ๒ Definitions**

“ Supervisor ” means a person who has the authority to order, supervise, follow up and inspect. Police officers under

“ Police officials ” means police officers under Chaturaphukpimarn Police Station .

“ Bribe ” means property or any other benefit given to a person in order to induce that person to act or not. Do any act in the position, regardless of whether it is right or wrong with duty.

“ Performance of duty ” means an act or performance of duty by a government official in a position appointed or assigned to perform any duty or to act on behalf of him in any duty one both in general and specifically as police officers whose powers and duties have been established by law

“ gifts, tokens or any other benefits that affect the performance of duties ” means money, property Any other services or benefits that are of value and include tips which government officials receive in addition to salary income Benefits from government service in normal cases and affect decision-making authorization or any other practice The duty shall be in a manner that facilitates dishonest benefits to the gift giver either in the past or while receiving or in the future.

### **Article ๓ Scope of application**

Announcement of Chaturaphukpimarn Police Station on Anti - Bribery Policy and No Gift Acceptance Gifts or other benefits ( No Gift Policy) from performing duties in the fiscal year ๒๐๒๓ This issue shall apply to police officers under Chaturaphukpimarn Police Station

### **Item ၃ Guidelines for conduct of police officers**

၃.၈ Do not ask , do not give or accept bribes, gifts, tokens or any other benefits from performing duties.

၃.၉ Not consenting or conniving for family members to give or accept bribes, gifts, tokens or Any other benefits to those involved in the performance of duties

၃.၁၀ The performance of duties must be based on law enforcement with fairness. take advantage and image of the police is important, must not take any action that is a conflict between personal interests and interests public such as accepting gifts, tokens or any other benefits that affect the performance of duties and use of government resources the use of objects for personal benefit; the disclosure of inside information The encroachment of official time for special work, etc.

၃.၁၁ Reduce the ethical giving or receiving of property or any other benefits in accordance with the criteria and the amount prescribed by the National Anti-Corruption Office by using the expression by signing greeting cards. greeting card, condolence card or using social media instead of giving things

၃.၁၂ Do not tolerate, tolerate, or ignore the behavior of accepting bribes, gifts, tokens or any other benefits from duty If any violating action is found, inform the Superintendent /Station Leader as soon as possible.

၃.၁၃ Supervisors behave as good role models, supervise and supervise their subordinates to perform their duties according to this announcement.

### **Article ၄ Monitoring and auditing**

The commanding officer shall have the power and duty to supervise, follow up and inspect the police officers under his affiliation to perform their duties in accordance with this announcement. In case of any acts that violate this announcement are found, report to the Superintendent /Station Head as soon as possible.

### **Article ๖ Examination of facts**

In case of receiving complaints/clues Subordinate personnel committing such offenses at the police station will investigate the facts. According to the process of investigation of fraud in the performance of duties. and report the progress to the complainant

### **Article ๗ Penalties**

In the event that the facts are examined and it is found that the police officer has actually committed an offense , if it is a criminal offense to prosecute criminal proceedings If it is a disciplinary offense, proceed with the appointment of an investigation committee according to the regulations. Violators will be punished strictly according to the relevant laws, rules and regulations . and deliver the matter according to the hierarchy of command

### **Article ๘ Complaint channels**

**Article ๔ Protection Measures for Complainants, Witnesses and Accused Persons**

**๔.๑ Protection measures for complainants and witnesses**

- Upon being notified of the preliminary corruption information to be treated as an official secret To conceal the name, last name, address or any other information that can identify the complainant. Then conduct a secret investigation to see if there is any truth or not.

- In case of fact-checking and finding that the informed clues are of great benefit to the agency The complainant should have the right to receive appropriate compensation such as favor or honor.

**๔.๒ Measures to protect the accused**

- Accept complaints only that specify the name, address, position or identity of the complainant. Only in the case of an anonymous complaint The position or identity of the complainant will not be considered unless the evidence is clearly stated. as well as pointing out certain witnesses only

- In the event that the complaint has no grounds for guilt To end the matter and report to the superior.

- In case of false complaints, disciplinary action will be taken . or report to the supervisor of the complainant's affiliation Take sanctions or criminal prosecution if the accused so wishes.
